THE CONDITIONS AND EXCLUSIONS OF QUAKER'S LIMITED WARRANTY ARE AS FOLLOWS:

Glass - 5 Year

Quaker warrants that under normal conditions, its factory installed insulated glass with Duralite spacers will be free from manufacturing defects for **five (5) years** from original date of purchase. Glass is warranted against stress cracks for **ninety (90)** days from original date of purchase. Laminated glass is warranted from manufacturing defects for **one (1) years** from original date of purchase. This limited warranty does not apply to special glazings.

Note regarding insulated glass containing argon gas fill:

Inert gas dissipates over time, and will dissipate at a more rapid pace when adding Capillary tubes to insulated glass. Quaker does not warrant the amount of inert gas present in insulated glass at any time after manufacture.

Simulated Divided Lites/Applied Grilles

Materials which are applied to the face of insulated glass for the purpose of simulating Divided Lites, are warranted from detaching from the glass surface for a period of **five (5) years** from original date of purchase.

Hardware

Window and door hardware (including non-electric operators, locks, lifts, balance systems, hinges, handles, rollers, insect screens, weatherstripping, and exterior trim) to be free from manufacturing defects for five (5) years. All other hardware not listed will be warranted to be free from manufacturing defects for one (1) year.

Painted Finish

Aluminum Product finish:

Anodized Finish: three (3) years 2604 Finish: five (5) years 2605 Finish: fifteen (15) years

Quaker warrants Aluminum exterior painted finishes from the date of invoice that they:

- Will not fade in color more than five (5) units as measured by Hunter L*a*b* Color Difference as set forth in ASTM D2244 Section 6.3
- Will exhibit gloss retention of a minimum of 30% of the original as measured in accordance with ASTM D523 using 60º readings
- Will not chalk in excess of standard number 8 ratings for colors, number 6 for whites as illustrated in the ASTM D64214 Test Method A
- Will not crack or peel in such a way as to significantly adversely affect the appearance of the surface to which the product has been applied and result in damage to the surface

Note: Certain high chroma shades of red, orange and yellow require a clear top coat to achieve the 5year South Florida weathering durability according to AAMA 2604-05

Exclusions to warranty coverage:

Product damage or defects resulting from the following are excluded from the warranty coverage:

- Installation or use near high humidity areas (pools, saunas, hot tubs, etc.)
- Normal wear and tear; including fading and/or discoloration from normal use, age or sun exposure
- Failure to paint, treat or properly seal exposed wood within 30 days of invoice date
- Minor imperfections in the glass that do not affect the structural integrity of the glass or do not permanently and materially obstruct vision
- Scratches or other imperfections not readily observable beyond four feet away
- Installation into structures that do not allow for appropriate water/moisture drainage. This
 includes but is not limited to "Exterior Insulation & Finish Systems" (EIFS), a.k.a. "Synthetic
 stucco".
- Accidents, explosion, misuse, abuse, vandalism, building settling, war, terrorism, acts of third
 parties beyond Quaker's control, Acts of God including but not limited to fire, flooding,
 earthquakes, hurricanes and gale force winds...
- Failure to follow Quaker care and maintenance instructions located at www.quakerwindows.com
- Glass installed or transferred in elevations above 5,000 feet MSL without capillary tubes
- Product modifications not factory installed by Quaker Windows
- Damage caused by use of expanding spray foams applied around the perimeter of product during the installation process, resulting in product distortion and/or issues with product operation and performance.
- Failure to properly install exterior trims, panning, subsills, receptors
- Improper caulking used to seal frames or trim packages
- Improper installation, flashing, wall/project design/construction, storage, or handling, or structural failures of walls or foundations
- Field mulling, Field finishes
- Abnormal weather conditions, hail, exposure to excessive heat (in excess of 150° F), acid rain, salt water, condensation and any damage related to condensation unless due to insulated glass failure
- Damage caused by chemicals (brickwash, hydrochloric acid, muriatic acid), tapes or sealants
- Damage during handling, shipping, processing or installation
- Products that have not been paid in full.

Claim Notice

Within the warranty period, Quaker must be notified immediately, and in no case more than thirty (30) days for glass and one (1) year on all other items, after any defect or other basis of a claim covered by this Limited Warranty is discovered or should be discovered. Any claims made after this time period will be excluded from Quaker's warranty coverage.

Condensation

Condensation is not a product defect, but the result of excess humidity. Condensation, frost, mold, mildew, or fungus on product surfaces is not covered by the Residential Warranty.

Impact windows and doors:

Quaker's impact windows and doors have been designed to meet or exceed codes mandated by legislation for areas where high winds and wind-borne debris may occur.
